User Agreement

The Terms and Conditions (T&C) contained herein along with the [Privacy Policy](#) and Terms of Use, form an Agreement regulating our relationship with regard to the use of Gain More Soft Tech Solutions LLP 'www.gainmoresofttechsolutions.com' 'Gain More' Mobile Application and its Platforms (Site) by you.
